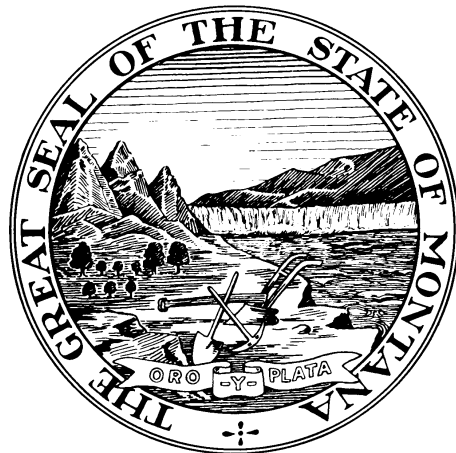

2003 LAW ENFORCEMENT PERSONNEL

Background

Annually the Montana Board of Crime Control conducts a survey regarding manpower of the state's local law enforcement agencies. The survey is used to gather information about the type and number of personnel employed by these law enforcement agencies as of October 31 of that year.

The law enforcement agencies include Police Departments, county Sheriffs' Offices, State Agencies whose employees have the power of arrest, Tribal Law Enforcement Agencies, University Security forces, and Airport Securities. Not included in the survey are federal employees working in Montana (e.g. Federal Bureau of Investigation, Drug Enforcement Agency, and Border Patrol.)

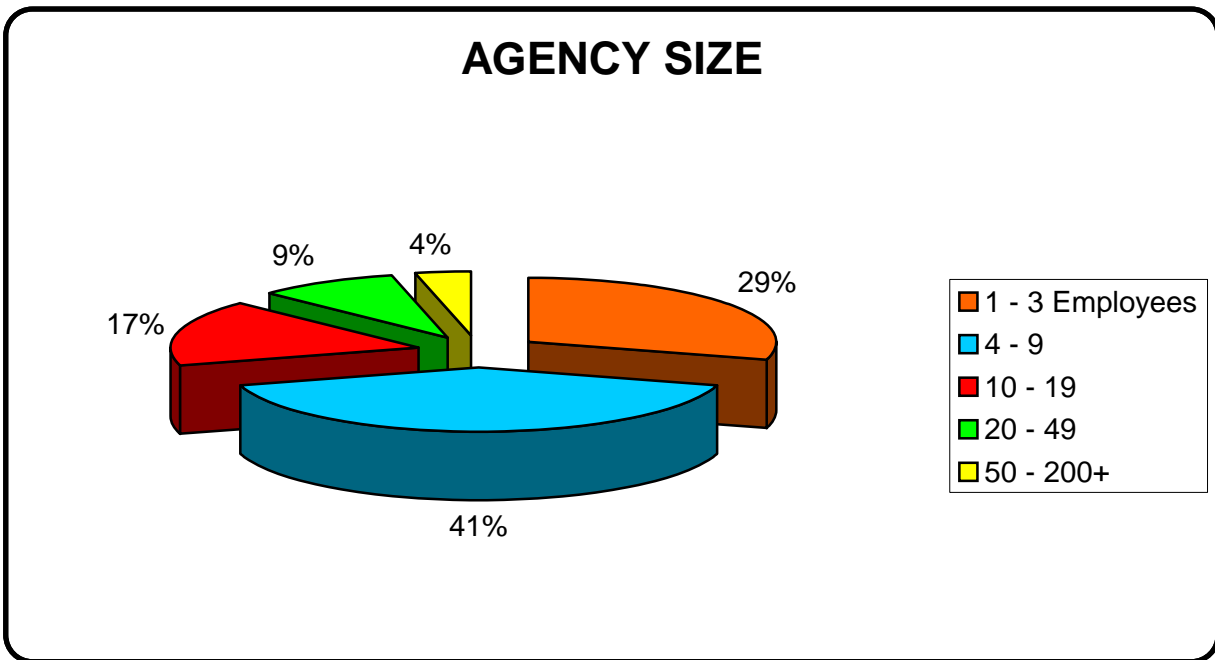

A total of 131 law enforcement agencies responded to the 2003 survey. Information for two agencies was not available. The Board of Crime Control would not be able to present this information if it were not for the cooperation of these law enforcement agencies. The effort and time that went into completing the survey are greatly appreciated.

Sworn Personnel

Sworn officers are those with the power to make arrests. A sworn officer may be either a staff or line officer. Staff officer functions are primarily administrative, while a line officer basically provides direct services. The number of sworn officers statewide decreased just slightly from 2002 to 2003. On October 31, 2003, there were 1,979 full-time sworn law enforcement officers. This number represents a 2.2% decrease since 2002, compared to a 1.0% increase in the estimated population over the same period. The count and categories of sworn officers can be seen in Chart A on the previous page.

Police Departments account for 50.1% of the 1,350 sworn officers in local and county law enforcement, while Sheriff's Offices account for 49.9% of this total. The size of individual Police Departments and Sheriff's Offices is quite varied in Montana. In 2003, the smallest agency reported 1 sworn officer while the largest reported 129.

An estimated total population of 917,621 for 2003 was used to calculate the statewide rate per capita. The United States Department of Justice, Federal Bureau of Investigation provides this estimated population. In 2003 the statewide ratio of sworn officers in a combination of Sheriff's Offices and Police Departments, was 1.5 law enforcement officers per 1,000 Montanans.

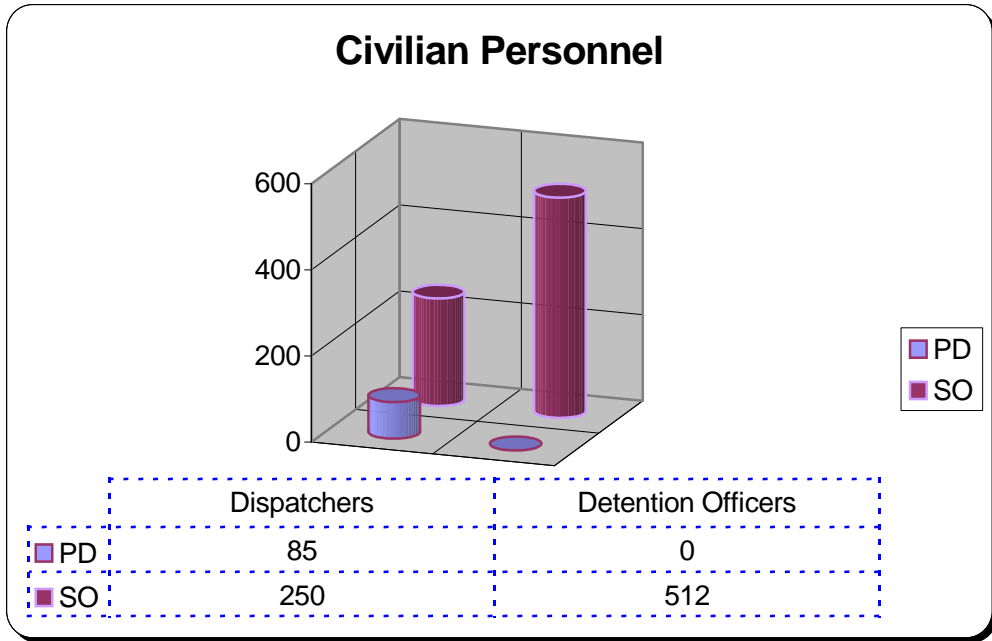

Civilian Personnel

Civilian employees in Sheriff's Offices and Police Departments typically include the detention officers, dispatchers, records personnel, and office staff. They do not have powers of arrest. A total of 1,082 civilian personnel, or 1.2 civilians per 1,000 Montanans, provided support for officers in Sheriff's Offices and Police Departments in 2003. This represents a 4.0% increase over the 1,040 civilians employed in 2002. Civilian personnel represented 44.5% of the total number of Sheriff's Offices and Police Departments' full-time employees in 2003.

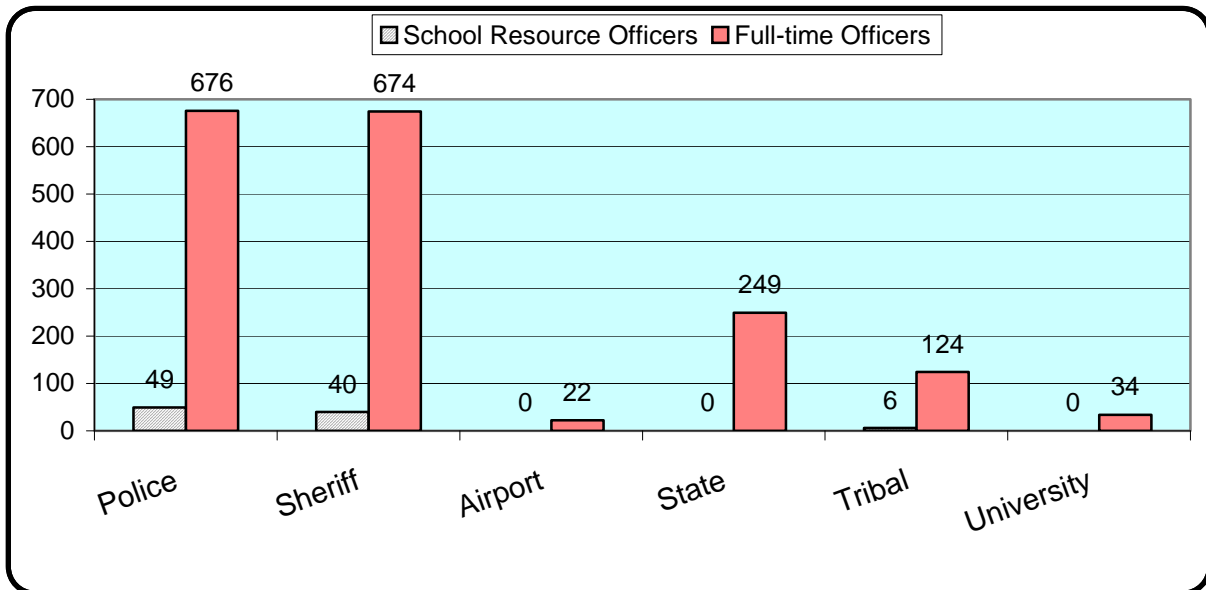

Resource School Officers

Out of the total full-time sworn, part-time, and reserve officers statewide, 95 are Resource School Officers. The Police Departments employ 49, Sheriff’s Offices 40 and Tribal Law Enforcement Agencies 6.

Montana Law Enforcement by Gender

The percentage of females employed as full-time, sworn officers in Police Departments and Sheriff's Offices increased slightly over the past year. Women accounted for 5.9% of all sworn officers in 2002 while they represented 7.0% in 2003. On a statewide basis, for all types of law enforcement, female officers represented 6.0% of the total sworn officers in 2003, compared to 6.3% in 2002.

Part-time and Reserve Personnel

Part-time law enforcement officers have the same powers as full-time officers. They are sworn and have full powers of arrest. Reserve personnel are part-time, volunteer members of a law enforcement agency. The appointing authority has control of a reserve officer's scope of authority.

Police Departments hired 10.6% less sworn part-time officers and reserve officers between 2002 and 2003. Police Departments employing sworn part-time officers, reserve officers, or both in 2003 decreased from 2002 by 1 department. The number of Sheriff's Offices hiring sworn part-time officers and/or reserve officers in 2003 also decreased from 2002 by 11 offices. In 2003, Sheriff's Offices employed 2.3% less sworn part-time officers and reserve officers than they did in 2002.

In 2003, 72.3% of Montana's Sheriff's Offices and Police Departments employed part-time officers, reserve officers, or both which is down from 83% in 2002. Reserve and part-time officers totaled 567 in 2003 from 589 in 2002. This indicates a 3.7% decrease in reserve and part-time officers.

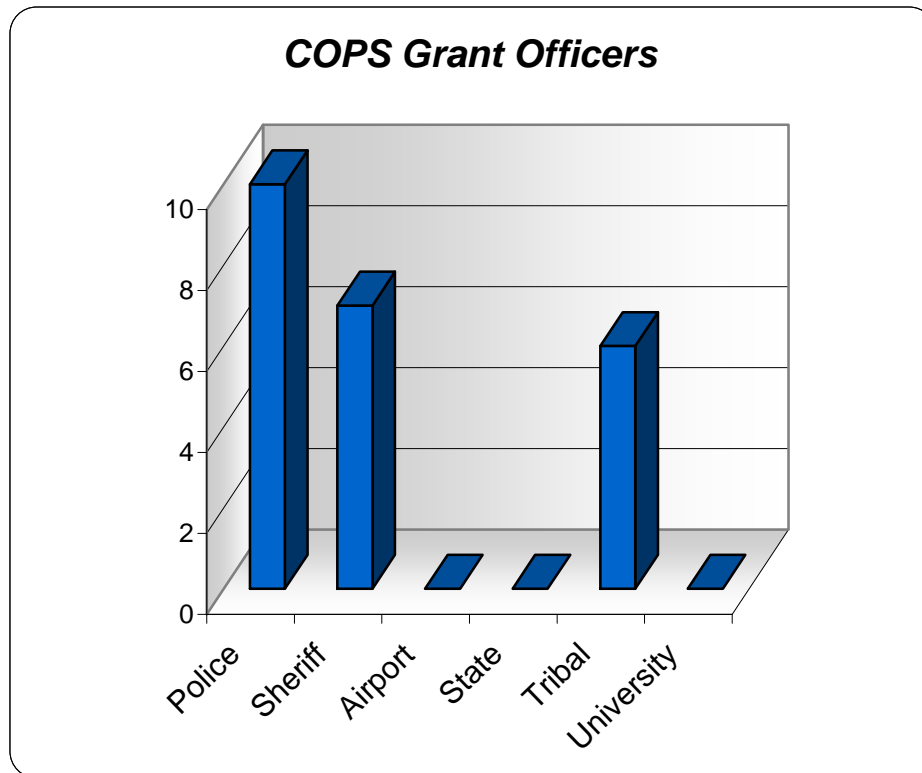

COPS Grant

Police Departments and Sheriff's Offices plan to hire a total of 17 COPS Grant officers in the next 6-12 months. Six officers will be hired by the Tribal Law Enforcement Agencies and none by the University Security, Airport Security or the State Agencies. This total of 23 COPS Grant officers has decreased from 42 in 2002, or by 45.2%.

State Agencies

The State Agencies included in this survey are as follows: The Criminal Investigation Bureau, Gambling Control Division, and Montana Highway Patrol all within the Department of Justice; Motor Carrier Services with the Department of Transportation; game wardens with the Department of Fish, Wildlife and Parks and brands inspectors with the Department of Livestock.

Chart H indicates the number of sworn law enforcement personnel for each State Agency in 2002 and 2003. The number of sworn officers remained relatively constant for the majority of State Agencies over this period with an increase of just 1 officer.

Tribal Law Enforcement

Tribal Law Enforcement Agencies have jurisdiction over Montana's seven Indian reservations. The Tribal Agencies included in this survey are as follows: Crow Agency, Flathead Agency, Fort Belknap Agency, Fort Peck Agency and Northern Cheyenne Agency. Chart I on the next page displays each agency's count of sworn officers.

Compensation

Chart J shows the average starting salaries for all sworn line officers employed in Montana, as well as the average salaries of chief administrative officers. The highest statewide annual salary reported for a chief administrative officer was \$90,643.00 and the lowest was \$21,424.00. Law enforcement officers' starting salaries ranged from a high of \$38,184.76 to a low of \$18,628.60.

The average salary for a sheriff was \$36,923.88 in 2003, while it was \$37,300.47 in 2002. This represents a decrease of 1.0% over the period. The average starting salary for a deputy in a sheriff's office was \$27,661.59 in 2003, compared to \$27,613.74 in 2002. This is a .2% increase in starting deputies' salaries for the period.

The average salary for a police chief was \$40,389.77 in 2003, compared to \$38,698.77 in 2002. This represents an increase of 4.4% over the period. The average starting salary for an officer in a police department was \$26,417.18 in 2003, while it was \$25,167.89 in 2002. This is a 5.0% increase for the period. The Pinesdale Police Department operates on a voluntary basis.

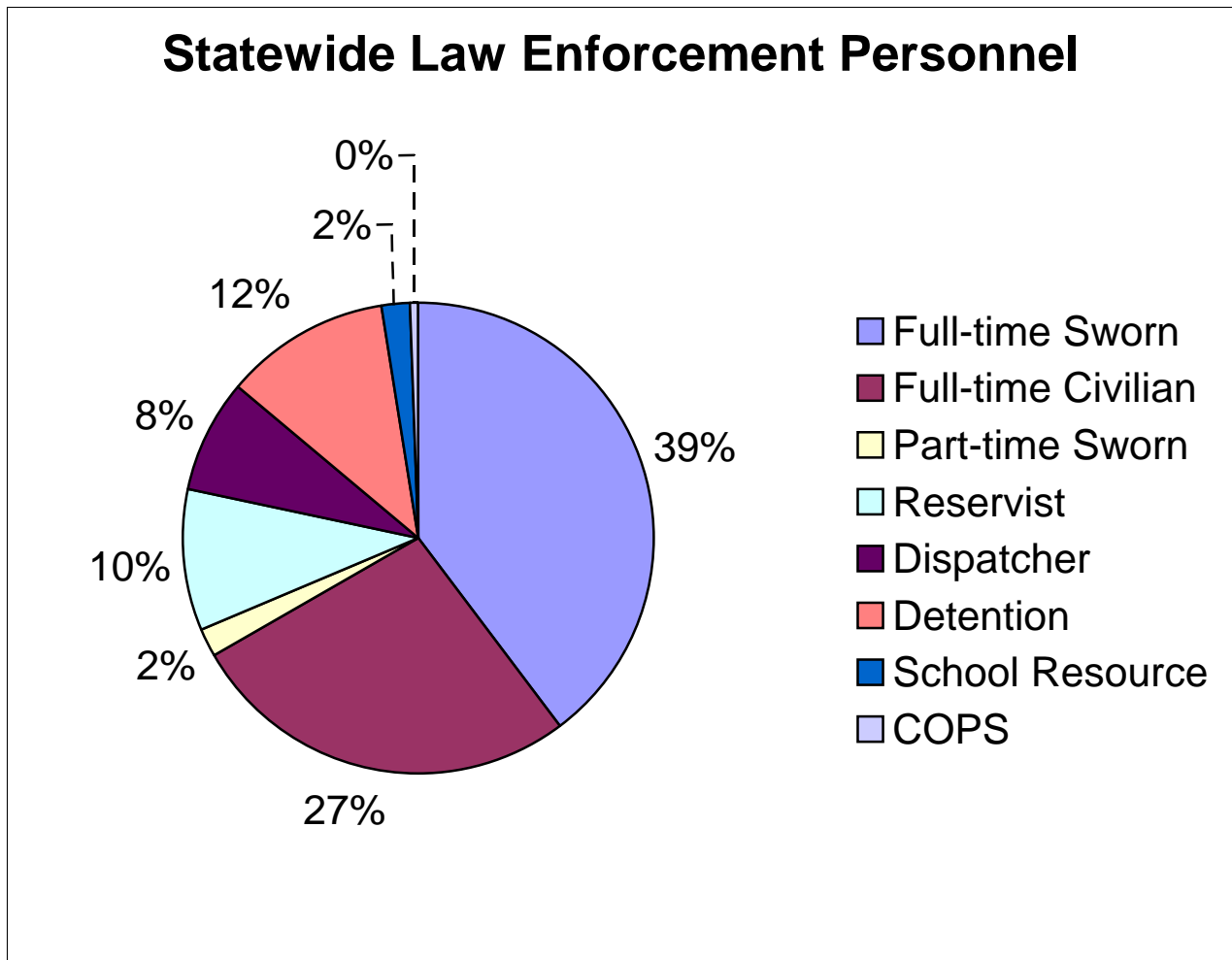
