

• Why do we reach out about these particular offenses?



- Throughout the year, we reach out to agencies when certain offenses are submitted.
 We do our best to reach out around submittal date, but sometimes we get a little behind due to other priorities.
- Yes, believe it or not, these offense sometimes get submitted in error
- Burglaries only by direction of the FBI when something within the incident seems a little "amiss"

Homicides

- A homicide is the killing of one person, by another
- Due to the severity of the crime, these are carefully monitored by the FBI and SAC Staff
- Why we might reach out:
 - No media coverage of the incident, including online, television, etc.
 - Potentially an Attempted Homicide?
 - Coverage of the incident but no NIBRs submission
 - Basic information in incident = submit!
 - Infinite number of incident updates
- Montana has a lower than average Homicide rate compared to the rest of the country
- Currently, the FBI only requests numbers on Deliberate and Negligent Homicide they
 do not request information on our DUI Vehicular Homicides, which we have had three
 this year.
- Many of those in law enforcement are still under the impression that an incident cannot be submitted until the investigation is complete – this is inaccurate. As soon as you have basic information on an incident, any incident, it can be submitted and then later updated an infinite number of times.


Hate Crimes

- A hate crime is a "committed criminal offense which is motivated, in whole or in part, by the offender's bias(es) against: race, religion, disability, sexual orientation, ethnicity, gender, gender identity"
- Hate Crimes are carefully monitored by the FBI and SAC Staff
- For systems on the flat file system, we reach out regarding EVERY crime listed with a bias
- For systems on XML, narratives are automatically submitted to us when a crime is listed with a bias
- Remind your officers NOT to select "unknown" unless they have evidence to suggest that it was possible element!

Cargo Theft

- A cargo theft is "the criminal taking of any cargo including, but not limited to, goods, chattels, money, or baggage that constitutes, in whole or in part, a commercial shipment of freight moving in commerce"
- According to the FBI, cargo theft is a multi-billion-dollar criminal enterprise in the U.S.
- Of the 31 that were submitted to us last year, 3 were confirmed as cargo thefts
- For systems on the flat file system, we reach out regarding EVERY crime listed as a cargo theft
- For systems on XML, narratives are automatically submitted to us when a crime is listed as a cargo theft

Must be within the delivery pipeline. Not for UPS/FedEx items stolen off door steps.



Burglaries

- SAC Staff do *not* monitor all burglaries that are submitted
- > The FBI does monitor certain burglary elements, including:
 - Number of premises entered, I.E., the "hotel rule"
 - Property Value Loss
 - Agency Trends
- The FBI contacts SAC if an element needs to be verified, such as:
 - An Item Valued at \$1,000,000
 - Location listed as residential, but 19 premises entered

Bottom Line...

- We trust agencies to enter accurate data & only reach out when absolutely necessary
- The human element we all make mistakes!
 - Officer fumbles
 - Programming issues
 - Repository bugs
- Strive to ensure integrity of ALL data!
