## 2022 Montana Crime Prevention Conference

Multi-Disciplinary Solutions for Public Safety

The 2022 Montana Crime Prevention Conference took place at Fairmont Hot Springs on **October 4th and 5th, with post-conference training** on **October 6th and 7th.** There was an excellent turnout with 180 attendees across all sessions.

The Opening Ceremony began with the National Anthem, performed by the Anaconda Schools Choir, followed by the Presentation of Colors by the Lewis & Clark County Honor Guard. Sheriff and MBCC Chairman, Leo Dutton, delivered opening remarks, blessings, and welcomed everyone to the 16th Annual Montana Crime Prevention Conference.

Following the Opening Ceremony, Ken Scott delivered a powerful keynote speech about his experience surviving two consecutive avalanches against impossible odds and why we need to redefine resiliency and hold ourselves and others to a different standard.

Attendees were grateful for the opportunity to hear from Governor Greg Gianforte during his Fireside Chat. Governor Gianforte and Lewis & Clark County Sheriff and Coroner Leo Dutton discussed the importance of law enforcement, efforts to improve public safety in Montana, and how to collaborate across disciplines to create meaningful solutions and impactful change.

MBCC honored the 2022 Lifetime Achievement Award recipient, Tammy K Plubell, and the 2022 Innovative Community Improvement Award recipient, Lea Wetzel at the Tuesday, Awards Luncheon. MBCC thanks Community Medical Services for sponsoring the Tuesday Awards Luncheon.

The Montana Department of Justice Office of Victim Services presented the Victim Advocate of the Year Award to Jamie Rogers, Bureau Chief of the Montana Department of Corrections Victim Services.

Attendees had the opportunity to attend sessions from Victim Services, Law Enforcement, and General tracks. There were two breakout sessions for each track on both Tuesday and Wednesday and one lunch session on Wednesday for a total of 13 presentations.

MBCC Staff facilitated a Subgrantee Training on Thursday while Kevin McKinerny, Patrick Moody, Devin Keller, and Courtney Cosgrove delivered Commercial Cannabis Investigations training. Rodney Toulson led Restorative Practices Training on Thursday and Friday.

### 2022 Lifetime Achievement Award

Tammy K Plubell



The Montana Board of Crime Control honored Tammy K Plubell with the 2022 Lifetime Achievement Award in recognition of her contributions to the criminal justice system. For thirty-seven years, Tammy has worked with children. families. social workers, law enforcement, and the medical community to reform the justice system. She was the driving force behind the child evaluation center in Great Falls and overhauled the Cascade County youth in need of care system. She headed a commission to study criminal sentencing policy, prepared a comprehensive report for improving the sentencing system, and saw the visions from her report implemented by the Legislature in 2017.

Tammy has shouldered Montana's most egregious, notorious, and challenging cases and is the "go to" source when a County Attorney has a vexing legal problem. Her service, professionalism, vision, innovation, grit, and commitment set her apart. Tammy is never out-prepared and never out-worked because she knows victims and prosecutors are depending on her.

## 2022 FBI NIBRS Training

#### Improving Crime Data for the Next Decade

The FBI offered National Incident-Based Reporting System (NIBRS) Training for the western region on September 27-29. Montana has been collecting NIBRS data since 2004. Over almost twenty years, issues were discovered that make data entry difficult; or cause data inaccuracies when FBI rules conflict with state laws.

In 2019 Montana received funding to replace an end of life data repository. This repository included system enhancements to resolve the issues identified over the last twenty years. These enhancements were developed in collaboration with Montana Law Enforcement, their records management vendors, the repository vendor and the FBI. Montana also consulted other state programs and national associations.

Montana Statistical Analysis Center (SAC) staff worked with the FBI to receive their training presentations in advance to enable us to extract FBI requirements that have been modified for Montana. This presentation followed the final FBI training session so that we were able to provide timely responses to agencies. Immediacy was important as many of the enhancements remove the NIBRS burden from law enforcement to the Montana SAC, contradicting a number of the training points.
