Justice applications, amended and approved the Byrne State Crisis Intervention Program (SCIP) strategic plan draft, appointed new members to the Executive Committee, and presented the 2023 Spring Certificate of Outstanding Program to the Southwest Montana Drug Task Force.

#### Southwest Montana Drug Task Force

The Montana Board of Crime Control presented the Southwest Montana Drug Task Force (SWDTF) with the Spring 2023 Certificate of Outstanding Program Award at the 2023 March Board Meeting in Helena, MT.

Steve Crawford, Marty Heaney, and Chad Anderberg presented before the Board on the important work SWDTF does, including the two-year investigation that dismantled a significant drug trafficking organization with ties to the Sinaloa Cartel, which brought in massive quantities of methamphetamine, counterfeit pills containing fentanyl, and heroin to Montana.

The deadline to submit student essays for the 2023 Do the Write Thing challenge was March 10, 2023. MBCC estimates as many as 566 students participated in the challenge across seven schools with 130 total student submissions.

Staff has started the scoring process and expects to announce ten State Finalists in April and two National Ambassadors in May.

MBCC will host a state-level celebration on **May 20, 2023** and the National Ambassadors will receive a trip to Washington, D.C. on **July 15 - 19, 2023**.



## **Elder Abuse Investigations First Responder Training**

The Elder Justice Taskforce has been busy this last quarter. The taskforce had the opportunity to connect with crucial later-in-life abuse partners. These partners include law enforcement, APS investigators and social workers, and grass-root advocates. These connections allowed the taskforce to work with Missoula Police Department and the Elder Justice Taskforce to put on a training for first responders that focused on elder abuse investigations. The training focused on interactions and interviews with later-in-life abuse survivors and the signs to be aware of during an investigation. The training involved essential partners such as the Department of Criminal Investigations' Elder Justice Investigator and Elder Justice Prosecutor and an APS Investigator from the Missoula office. The training was created with the help of YWCA Missoula. The taskforce looks forward to offering more training opportunities and learning from their partners!
