Friends of the Children

The Montana Board of Crime Control is pleased to announce the Spring 2024 Program Highlights recipient, Friends of the Children.

Friends of the Children disrupts cycles of generational poverty and cycles of trauma by pairing amazing children enrolled in the program with full-time, salaried professional mentors.

Their mentors, which Friends of the Children refers to as "Friends," are highly experienced youth-centered and trauma-informed professionals. Each Friend serves 8 youth and spends 4 hours per week with each child, engaging in one-on-one activities and time together in their schools, home, and community that foster positive social emotional growth and healthy connections to adults and their peers and help youth build important life skills.

MBCC Vice Chairman Rick Kirn presented Executive Director Ben Davis and Professional Mentor Tyler Taylor with the Certificate of Outstanding Program Award at the Quarterly Board Meeting on March 14, 2024. Mr. Davis kicked off the Program Highlights presentation to the board with an overview of the work Friends of the Children does and the impact they have had throughout Montana. Mr. Taylor shared his experience as a Friend and the positive changes he has seen in the children he has mentored.

Victim Liaison Project Update

The victim liaison project has conducted outreach to MBCC subgrantees to ensure completion of the Statewide Needs Assessment. Currently the victim liaison project is working with the Statistical Analysis Center to build a comprehensive map of victim services in Montana. They are working to ensure the map goes live by June of 2024. Since 2022, the state victim liaison have facilitated bi-monthly Educational Power Hours featuring presentations from various organizations, fostering collaboration and community while providing information about available programming throughout Montana. Efforts have also begun to integrate survivor experiences into MBCC's work, including collaborating on a survivor needs assessment and planning meetings with survivors in Billings.

Participants had the opportunity to earn continuing education credits and POST credits, further enhancing the value of this initiative. 
