# **High Risk Teams Update**

#### **APRAIS Lethality Tool Training**

The Arizona State University APRAIS training team assembled in Helena, MT on June 11 and 12 to train the local professionals in implementing the use of the APRAIS lethality tool. The APRAIS lethality tool provides risk information gathered by police from victims and alleged victims of Intimate Partner Violence (IPV) and is designed to connect the victim with support services while officers are on-scene. APRAIS provides criminal justice personnel and advocates with an evidence-based tool and protocol to gather information, which helps identify potential risk of severe re-assault, as well as lethal or near lethal intimate partner violence, and possible future threats to officers. APRAIS addresses the complexities of IPV and the need to identify dangerous cases. This training was funded by a discretionary grant, Improving Criminal Justice Response, under the Office on Violence Against Women.

#### 2024 Lifetime Achievement Award (LAA)

The Lifetime Achievement Award is presented to a deserving individual (or group of individuals) who has achieved professional excellence and made lasting contributions to improve Montana's justice system throughout their career. This award encompasses professionals across the entire justice system and includes law enforcement, crime prevention, public safety, victim services, juvenile justice, forensic science, prosecution, public defenders, courts, corrections and volunteers. The award honors an individual's proven leadership, vision, and innovation in their field.

#### **Submit Nominations for 2024 LAA**

#### 2024 Innovative Community Improvement Award (ICIA)

The Innovative Community Improvement Award is presented to a deserving individual (or group of individuals) who has, through a specific campaign or program, made lasting contributions to promote public safety and crime prevention within their community. This may include improving the quality of life, reducing the fear of crime, enhancing services to victims or initiating measurable, positive results. For the purposes of this award, a community is defined as a social unit of any size within Montana that shares common values, and may include towns or cities, a county, a specific region, an Indian reservation, etc. A community is not defined as the entire state. This award encompasses any professional or private community citizen or citizens, or a combination thereof. The award honors an individual's proven leadership, vision, and innovation resulting in lasting contributions and significant improvements to their community.

# New and Updated Subgrantee Procedures

**Updated - AmpliFund Required Documentation for Expenses** 

The purpose of this procedure is to assist subgrantees in:

- 1. Understanding accounting reporting basis for expenditures and
- Knowing what type of backup documentation is required to upload into AmpliFund when entering expenses and before MBCC staff can issue a payment to a subgrantee.

The recipient (and any "subrecipient" at any tier) must have written procedures in place to respond in the event of an actual or imminent "breach" of PII.
