MBCC is currently accepting Program Highlights for the Spring quarter.

Up to two representatives from the selected program will be invited to give a presentation about their program to the Board of Directors at the Board Business Meeting on **March 6, 2025.** MBCC will showcase the Highlight Program through a statewide press release, certificate of recognition, and placement of program information on the MBCC website. Additionally, the selected program will receive one attendance scholarship to the 2025 Montana Crime Prevention Conference.

The 2025 Do the Write Thing Challenge has begun!

All across America, students are taking action to end youth violence. Montana's Do the Write Thing Challenge is a violence prevention program that encourages middle school students to examine the causes of youth violence, the impact of violence on their lives, and to communicate in written form what they think should be done to reduce youth violence. By encouraging students to make personal commitments to do something about the problem, the program ultimately seeks to give them the opportunity to break the cycles of violence in their homes, schools, and neighborhoods. Do the Write Thing is an initiative of the National Campaign to Stop Violence.

Student writings are due March 7, 2025. Nine State Finalists and one Student National Ambassadors will be selected and invited to the State Recognition Event in Helena in May 2025. The Student National Ambassadors will be invited to the National Do the Write Thing Recognition Ceremony in Washington D.C. in July 2025.
