## **December Board Meeting**

The Board made decisions on Title II and RSAT funding, approved VOCA Match Waivers and minor language changes to Board policies, and discussed funding priority criteria for the 2022 VOCA funding opportunity.

# 2022 Victims Funding Opportunities

MBCC is seeking applicants for the 2022 Sexual Assault Services Program (SASP), 2022 Domestic Violence Intervention (DVI) Program, and 2022 Victims of Crime Act (VOCA) funding opportunities.

Applications for SASP and DVI are due on January 26, 2022. VOCA applications are due January 27, 2022.

The 2022 STOP Violence Against Women Act (VAWA) funding opportunity will open in March 2022.

As the Montana Board of Crime Control liaisons, we wanted to provide you with a quick update on how our Victim Liaison Project has progressed. When we began emailing service providers around the state, we knew we would get good information, but honestly, everyone that we have met with so far has exceeded our expectations. We have learned, and are continuing to learn such solid, valuable information that is both helping us get the data we need in order to provide a statewide needs assessment that is effective in asking the right questions, and also learning what our great state already has and what gaps exist for victims in our current system. During our many one-on-one meetings and roundtable discussions with both systematic and grassroots organizations. we have been solution-focused and forward-thinking. We have also taken the time to really connect with our reservations and urban Indian centers, ensuring tribal entities are involved and tribal issues are included in this conversation. It is important to note, we still have many communities that we plan to visit, as the public health situation permits. We are gearing up to have listening sessions for victims of crime in both the Missoula and Helena areas and we are beginning to create our needs assessment. Most importantly, we want to thank everyone who has met with us and those who are still planning to meet with us. 



# 2021 Law Enforcement Personnel in Montana Report

Thank you to our Law Enforcement partners for 100% participation! MBCC conducts an annual employee survey of the state's law enforcement agencies, including police departments, county sheriffs' offices, and university police. The surveys are used to determine the number and type of personnel employed by Montana law enforcement agencies as of October 31 of each year.

For the first time ever – all listed state law enforcement agencies with sworn law enforcement officers responded – this included Airports, and state agencies such as DOJ Gambling Control Division, Motor Carrier Services Division, Division of Criminal Investigations, Department of Livestock, Probation and Parole, and Fish Wildlife and Parks. Thank you to all who participated! MBCC would not be able to present this information if it were not for the cooperation of these law enforcement agencies. The effort and time that went into completing the surveys are greatly appreciated.

The MBCC Statistical Analysis Center is in the process of building the 2021 Law Enforcement Personnel in Montana Report into an interactive data dashboard similar to those on the <u>Montana Crime Data</u> webpage. The report will be posted to <u>crimedata.mt.gov</u> when available.

# 2022 Do the Write Thing Challenge Incentive

#### Your School Could be Awarded \$1,000 for Participating

The Montana Board of Crime Control recently received \$5,000 from the national **Do the** *Write* Thing program to encourage local participation. MBCC anticipates awarding \$1,000 to schools with the highest percentage of seventh and eighth grade students submitting essays regarding youth violence. Sixth grade students may also participate if they attend the same school, but it is not required for the purposes of this incentive. Once awarded, schools may use the funds for anything they wish.

The deadline for essays to be submitted to MBCC has been **extended to March 1, 2022**. If you have not already done so, please notify MBCC if your school or classroom plans to participate.
